**The financial aid process can seem overwhelming.
It doesn't have to be.**

Financial aid is financial support that can help fund your degree at Anderson University. Types of financial aid include scholarships, grants, and loans. Sources of financial aid include, but are not limited to, Anderson University, the State of South Carolina, the U.S. Department of Education, and outside sources.

Scholarships are funds that do not need to be repaid and are typically awarded based on grades, test scores, and other merit-based qualifications.

Grants are also funds that do not need to be repaid and are typically awarded based on need.

Loans are funds that need to be repaid. After you complete a FAFSA, you will receive an award notice showing the aid you may be eligible to receive.

College is an Investment in Your Future

It's not like buying a new car. After all, the moment you roll out of the dealership's parking lot, it's already worth far less than you paid for it. And after a few years, it retains very little of its value. But the investment in a college education? It pays dividends for decades. Especially at a place like Anderson University.

But a college experience is about much more than money—it's about how college helps shape a person, how it affects his or her quality of life, and the potential to make a difference in the world.

The prospect of four years of college expenses can appear daunting. But if you value higher education and are committed to it—and it appears that you do, given the fact that you're reading the Anderson University Family Guide to College and Financial Planning—it's well worth the investment.

It requires choices, discipline, and a thorough investigation into financial aid options, of which there are many. (In the case of Anderson University, 100 percent of traditional students receive some sort of financial aid.)

Cost and value are not the same thing. You can be penny-wise and pound-foolish, especially when it comes to the vitally important college choice. You should choose a college because it is an excellent match for you, and a place where you'll feel at home—not because it is the least expensive. Like any investment, think long term. Ask yourself what impact choosing a college like Anderson University will have on the rest of your life.

In fact, do this: Estimate the cost of four years at Anderson University. Then amortize that total over 60 years by dividing the total by 60, and then dividing by 12 to get the monthly cost. If you do this, I'm guessing that you'll be surprised at that monthly total, and you'll consider it a good investment. In fact, if you compare this investment with the cost of a daily

The Value of a Christian Education

Recently, the Council for Christian Colleges & Universities (CCCCU), of which Anderson University is a proud member, released the results of a groundbreaking study that quantified more than just the value of a college education. It explicitly made the case for Christian higher education, a cause for which AU has been committed since our founding in 1911.



Our thesis is simple: Christian higher education is important to the social, cultural and economic well-being of the United States in general, and South Carolina specifically. In a political landscape scarred by the memory of the Great Recession, lawmakers have to ask hard questions and make bold decisions.

The overall economic impact of the more than 140 U.S.-based CCCU institutions is staggering. Collectively we generate \$60 billion annually for the U.S. economy, which comes out to roughly \$166 million per day. What's more, CCCU institutions employ 340,000 people, who earn \$17.8 billion in salary and benefits.

None of the CCCU institutions receive direct federal or state funds for operations, yet our students do receive federal and state grants and scholarships they can use at either public or private colleges and universities.

In light of the runaway federal deficit, and often-contentious debates in Congress on how best to allocate taxpayer dollars, cuts to grants and scholarships for college students wouldn't be prudent. After all, you'll not find many returns on investment better than that provided by Christian higher education.

When you drill down on the data, you find that the \$470 million in annual grant aid provided by the federal

government amounts to \$9.7 billion in federal tax revenue. Needless to say, a \$9 billion profit is an incredible return on investment.

Of course, it's not just dollars and cents. More than 35 percent of CCCU students provide out-of-classroom service to their communities, totaling 5.4 million hours every year. Graduation rates are high.

Our thesis is simple: Christian higher education is important to the social, cultural and economic well-being of the United States in general, and South Carolina specifically. In a political landscape scarred by the memory of the Great Recession, lawmakers have to ask hard questions and make bold decisions.

We certainly understand. In my view, however, it's vitally important that when considering federal- and state-based aid funding, lawmakers should keep their focus on the people most affected: the college students on whom so much of our country's future relies, and the young men and women schools like Anderson University so effectively educate.

The student was empowered by his or her family to make the final decision. We often believe parents and guardians always know best, and while that may be true, this is a choice that your student needs to feel equipped and encouraged to make. Families should provide guidance, support, and a knowledgeable perspective, but in the end, this decision must feel right to the student.

The student continued to receive support from his or her family once the decision was made. As your student selects his or her future home, you need to be firm in your support and unwavering in your encouragement. This is your student’s journey to navigate, and what he or she needs most is the recognition that you believe in the decision that was made.

You have a great opportunity to walk with your student through one of the most impactful seasons of his or her life, and your guidance right now is more crucial than ever.

Scholarships and Financial Aid for South Carolina Residents

Merit-Based Scholarships

SC PALMETTO FELLOWS*

— FOR FIRST-TIME FRESHMEN/TRANSFERS

- HOPE and LIFE recipients do not qualify.
- Recipients are selected by the South Carolina Commission on Higher Education.

SC LIFE SCHOLARSHIP*

— FOR FIRST-TIME FRESHMEN/TRANSFERS

- Palmetto Fellows and HOPE recipients do not qualify.
- First-time entering freshmen must meet two of the following three criteria:
 - 3.0 high school GPA (*SC uniform grading scale.*)
 - 1100 SAT or 24 ACT.
 - Top 30% of graduating class.

SC HOPE SCHOLARSHIP*

— ONLY FOR FIRST-TIME FRESHMEN

- This is a one-year scholarship for first-time entering freshmen.
- Must have a 3.0 high school GPA (*SC uniform grading scale.*)
- At the end of a SC HOPE recipient's first year, the student may be eligible to receive the LIFE Scholarship in subsequent years if he/she meets renewal requirements.

SC PALMETTO FELLOW AND LIFE SCHOLARSHIP ENHANCEMENTS*

— ENTERING FRESHMEN ARE NOT ELIGIBLE

- Must be a Palmetto Fellow or LIFE Scholarship recipient.
- Recipients must be a returning sophomore in a state-approved math or science degree program.
- Eligibility is determined by academic performance and credits earned during the freshman year of college.

— GRANT AMOUNTS VARY PER YEAR

PROVOST'S SCHOLARSHIP

- 3.0 high school GPA
- 1100 SAT or 22 ACT or 74 CLT
- or, top 20% of class

TRANSFER SCHOLARSHIPS

— FOR FIRST-TIME TRANSFER STUDENTS

- Awarded to first-time transfer students based upon cumulative college GPA.

DEAN'S SCHOLARSHIP

- 3.0 high school GPA
- 1020 SAT or 20 ACT or 66 CLT
- or, top 30% of class

PALMETTO BOYS AND GIRLS STATE SCHOLARSHIP

- Awarded to any first-time freshman or transfer.
- Must be named a Boys or Girls State citizen.

AU GRANT

- Awarded to any entering freshman not receiving a President's, Founder's, Provost's, or Dean's Scholarship.

SOUTH CAROLINA BAPTIST SCHOLARSHIP

- Awarded to any first-time entering freshman or transfer student who attended a Baptist church. Partially funded by a generous grant from the South Carolina Baptist Convention.

OUT-OF-STATE GRANT

- Awarded to any out-of-state entering freshman.

Academic Scholarships for First-Time Freshmen

Merit-Based Scholarships

SUMMIT SCHOLARSHIP

- Any student participating in Summit during their high school years is eligible for a yearly reoccurring scholarship.
- The prospective student must provide a certificate of attendance.

NCFCA SCHOLARSHIP

- Any student participating in NCFCA during their high school years is eligible for a yearly reoccurring scholarship.
- The prospective student must provide a certificate of attendance.

WORLDVIEW ACADEMY

- Any student participating in Worldview Academy during their high school years is eligible for a yearly reoccurring scholarship.
- The prospective student must provide a certificate of attendance.

Competitive Scholarships

These competitive scholarships are designed for the highest achieving, first-time freshman students who meet eligibility requirements. **Please note:** Test scores are required to receive consideration for competitive scholarships. An application to apply will be sent by exclusive invitation to all eligible recipients.

FELLOWS SCHOLARSHIP PROGRAM

— UP TO FULL TUITION, ROOM, AND BOARD

The Fellows Scholarship Program provides opportunities for first-time freshmen students who have demonstrated exceptional academic achievement, leadership, and mission-fit to Anderson University. The ability to apply for this scholarship is by invitation only.

Fellows Scholarship Program Opportunities

- Presidential Fellows: full tuition, room, and board scholarship
- Academic Fellows: full tuition scholarship and \$5,000 room stipend
- AU Fellows: full tuition scholarship

Scholarship Information

- Minimum eligibility to receive an invitation to apply is a 1250+ SAT or 27+ ACT or 82+ CLT AND 3.5 high school GPA.
- Recipients must serve in an approved campus leadership role each year.
- Annual award renewal amount is capped at the contract amount.
- Outside scholarships and federal grants and loans may be applied to cover room and board.

DENMARK SCHOLARSHIP

— FOR FIRST-TIME FRESHMEN

The Denmark Scholarship is a competitive scholarship reserved for first-time freshmen. The ability to apply for this scholarship is by invitation only.

Scholarship Information

- Minimum eligibility to receive an invitation to apply is a 1100+ SAT or 22+ ACT or 74+ CLT AND 3.0 high school GPA.
- Recipients must serve in an approved campus leadership role each year.

SINCLAIR AND BETTY LEWIS PRESIDENTIAL BOYS STATE SCHOLARSHIP

— FOR FIRST-TIME FRESHMEN

As the host for South Carolina's prestigious annual Sinclair and Betty Lewis Palmetto Boys State summer leadership program, Anderson University has committed one \$40,000 scholarship (\$10,000 per year) to a Palmetto Boys State Citizen. Anderson University is also privileged to offer a number of other scholarship opportunities to students who apply for the Sinclair and Betty Lewis Presidential Boys State Scholarship. All participants of Palmetto Boys State will receive an invitation to apply for this scholarship.

VISUAL & PERFORMING ARTS SCHOLARSHIP

— ART + DESIGN PORTFOLIO REVIEW

- A portfolio review is **RECOMMENDED** for all students planning to major in Art + Design.
- Students are invited to compete for a portfolio-based visual scholarship (amounts will vary.)

— MUSIC AUDITION SCHOLARSHIP

- An audition is **REQUIRED** for all students planning to major in music.
- Students are invited to compete for a performance-based music scholarship (amounts will vary.)

— THEATRE & DANCE AUDITION SCHOLARSHIP

- An audition is **REQUIRED** for all students planning to major in Theatre or Dance.
- Students are invited to compete for a performance-based theatre scholarship (amounts will vary.)

INTERIOR DESIGN SCHOLARSHIP

- An application and portfolio review are **RECOMMENDED** for students interested in earning an Interior Design Scholarship (amounts will vary).
- Prospective students are offered an opportunity to participate in a hands-on learning experience during Anderson University's annual **Interior Design Workshop**.

COLLEGE OF CHRISTIAN STUDIES SCHOLARSHIP

- You must be accepted into the College of Christian Studies.
